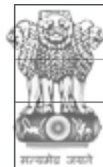

The two-bid system will be followed for this tender. Bidder is advised to carefully read this tender document before submitting his/her bid. In this system bidder must submit his offer in two separate sealed envelopes super scribing the envelop “**Tender for construction of one stall at (49th International Kolkata Book Fair-2026)**” at Boimela Ground, Central Park Mela Ground, Karunamayee, Sector - III, Salt Lake, Kolkata.

Tender may be downloaded from Central Public Procurement Portal, GeM and NBT's Website i.e. www.nbtindia.gov.in. Vendors are hereby invited the rate for fabrication of stall along with electrical fittings and sale counter for Kolkata Book Fair to be organized during the current financial year 2025-26 from eligible contractors having minimum experience of three years with Central or State Govt. or Public Sector Undertaking/Autonomous bodies of providing similar services with average turnover of Rs. 10.00 lakh or more in each of three financial years i.e. 2022-23, 2023-24 and 2024-2025

Terms and Conditions

Pre-Qualification Criteria:

The tender is based on two bid system. The tenderer shall submit his/her bid after downloading the Tender from CPP Portal, GeM and NBT's website in two separate categories marked "**Technical Bid - Fabrication of Stall**" and the second one marked "**Financial Bid - Fabrication of Stall**".

Technical Bid:

This shall form the basis of ascertaining the Technical and Financial credentials of the tenderer and also the suitability of Firm. The technical bid will be evaluated in terms of **Annexure - I** of the tender document. **The tenderers are advised to submit all supporting documents/information to examine the bids for qualifying for opening of financial bid.** This envelop of technical bid containing the required documents must super scribe "**TECHINICAL BID- Fabrication of Stall**" and should be sealed.

Financial Bid:

This shall consist of rate **Annexure - III** for Financial Bid and the tenderers are advised to fill the rate only in the format specified (**Annexure - III**) herein in accordance with the instructions and other relevant provisions mentioned in this tender document.

Please ensure that Technical Bid should accompany the EMD of Rs. 20,000/-, failing which the Technical Bid shall be rejected.

Bidder shall not be permitted to withdraw their offer or modify the terms and conditions thereof after acceptance of tender. In case the Bidder fails to observe and comply with the stipulations made herein or backs out after quoting the rate, the aforesaid amount of Earnest Money Deposit and Performance Security, will be forfeited by NBT - India. Besides this, the Bidder will also be liable to be debarred/blacklisted from participating in the tendering process of NBT - India in future, and/or be fined.

No claim shall lie against NBT - India in respect of erosion in value or interest on the amount of Earnest Money Deposit or Security Deposit. Only those parties, who have asset/infrastructure to complete the job, are requested to apply. The infrastructure facilities are subject to verification by the NBT - India.

The firm registered with MSME may be considered for exemption of Earnest Money Deposit as per rule.

Performance Security:

Before award of the contract the successful bidder will be required to deposit Performance Guarantee (refundable) a sum equivalent to **40,000/-** in the form of a NEFT/RTGS drawn in favour of **National Book Trust, India**, payable at **Kolkata**. The Performance Guarantee deposited shall be released by the NBT- India after successful completion of the contract in all respect.

The acceptance of a bidder will rest solely with the Competent Authority of NBT - India, who is not bound to accept the lowest bid and reserves the authority to reject any or all the bidding without assigning any reasons whatsoever. All tenders in which any of the prescribed conditions are not fulfilled, or are incomplete in any respect are liable to be rejected.

The items given in the specification of work (**ANNEXURE - II**) are approximate. Requirement of quantity/ items mentioned in the schedule may increase or decrease as per the decision of the Competent Authority of NBT - India and no claim in this regard shall be entertained. If considered necessary, any item could be dropped completely

NBT - India has the right to amend the tender document at any time before the closing date of the Bids.

Any modification/corrigendum issued with regard to this bidding document will be uploaded only on CPP Portal as well as NBT - India's website. Bidders are, therefore, advised to visit the CPP Portal and NBT - India's website in bidding section regularly till the last stipulated date of issuance of the bidding document for ascertaining any modification/corrigendum issued in this regard.

The approved Contractor should visit the Book Fair Venue/Ground and submit the layout/design of the Book Fair site to In-Charge (ERO, National Book Trust, India) prior to the start of the Book Fair for final vetting. In case of any changes in the layout/design the same shall be informed to the Contractor and accordingly to produce the same without any extra cost.

Incomplete quotation is liable to be rejected. If there is a discrepancy in rates between words and figures, the amount in words will prevail.

The quotation should fill the rates both in figures as well as in words. The quotation form shall be filled in **English** and all entries must be handwritten in dot pen. Overwriting of rates is not permitted. Corrections, if any, should be attested by the owner with his full signature.

Work must be completed by **6.00 p.m. on 20th January 2026 at the allotted space for NBT's Stall** in all aspects and has to be handed over to NBT - India in writing indicating the date and time. After 20th no work shall be allowed by the In-charge of Book Fair.

It will be the responsibility of the contractor to take a comprehensive insurance cover against fire, damage, pilferage, etc. at his own cost. He should take necessary precautions and provide safety measures to safeguard against possible hazards/accidents.

The quality of material to be used for the construction should conform to the approved design available in the softcopy. Any deviation in quality will render the contractor liable to penalty as may be decided by the NBT - India. The decision of the NBT - India in this regard shall be final and binding on the contractor.

The correction in design and material if any will be intimated and has to be incorporated by the vendor.

The payment of the billed amount will be made subject to a physical verification by the officers of the NBT - India. TDS & TDS (GST) shall be deducted as applicable under the rules. **Permanent Account Number (PAN) allotted by the Income Tax Authorities must be quoted in Annexure - I,** without which the quotation is liable to be rejected.

During the period of construction of stalls, the contractor shall have to make his own arrangement for various amenities necessary for the smooth execution of his work.

The contractor will be responsible for the up-keep and maintenance of the entire structure of stalls constructed by them till the end of the fair without any extra payment. Breakage and damages, if any shall immediately be replaced/repared without any extra cost.

One contact person / official of contractor shall be present for the entire period of fair to see overall arrangement.

Penalty of non-compliance of work on scheduled time will be imposed @ 2% of the total bidding value per day for delay in Job done.

The bid submitted by the tenderers shall be valid for a minimum period of 30 days computed from the date of opening of the bid.

Force Majeure

Neither party shall be in default if a failure to perform any obligation hereunder is caused solely by supervening conditions beyond that party's reasonable control, including acts of God, civil commotion, strikes, acts of terrorism, labor disputes and government or public authority's demands or requirements.

Breach of terms and conditions.

In case of breach of any of terms and conditions mentioned above, the Competent Authority will have the right to cancel the work order/job without assigning any reason thereof and no amount will be payable by NBT - India in that event and the security deposit shall also stand forfeited and the contractor will be blacklisted for work in future.

Subletting of work

The firm shall not assign or sublet the work/job to any other person or party or joint venture consortium will not be allowed.

Arbitration

If any difference arises concerning this contract, its interpretation or the payment to be made hereunder, the same shall be settled by mutual consultations and negotiations. If attempts for conciliation do not yield any results within a period of 3 months, either of the parties may make a request to the other party for submission of the dispute for decision. The NBT - India shall reserve right to nominate sole Arbitrator. Such request shall be accompanied with a panel of names of three persons to act as the sole arbitrator. In case of such arbitrator refusing unwilling or becoming incapable to act or his mandate having been terminated under law, another arbitrator shall be appointed in the same manner from among the panel of three persons to be submitted by the claimant. The arbitration proceedings shall take place at New Delhi and shall be conducted in English. The provisions of The Arbitration and Conciliation Act, 1996 and the rules framed there under and in force shall be applicable to such proceedings.

Legal jurisdiction

The agreement shall be deemed to have been concluded in the National Capital Territory of Delhi as head quarter of NBT - India is Nehru Bhawan, 5, Institutional Area, Phase - II, Vasant Kunj, New Delhi and all obligations hereunder shall be deemed to be located at the NCT of Delhi, and the Courts within NCT of Delhi only will have jurisdiction to the exclusion of all other Courts.

Validity of Bid

The work order shall be valid till the Financial Year 2025-26 or completion of Book Fair, whichever is earlier. In case the Book Fair is not organized due to unavoidable reasons/any other reasons during the Financial Year 2025-26, the contract will be treated as cancelled.

The decision of NBT - India with regard to all terms & conditions shall be final and binding.

Criteria for Evaluation of Bidding

NBT - India will examine the Bidders' documents to determine whether they are complete, whether any computational errors have been made, whether the uploaded documents have been properly signed, and whether the bidding is in order.

NOTE:

As per the guidelines of the Ministry of Finance, Government of India, the payment will be made through e-Payment mode and the successful bidder will have to submit his/her RTGS details along with a cancelled cheque.

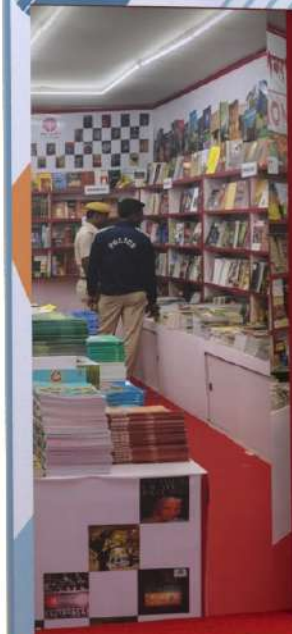
