TERMS & CONDITIONS

- 1. Standard size of Book stall: 3m X 3m**
- 2. Draw of the book stall will be done by National Book Trust, Delhi**
- 3. Last date of registration is 20th April 2012**
- 4. Municipal Commissioner, A.M.C.'s decision regarding application received after last date will be final.**
- 5. The participant will have to hand over the book stall post book fair in the original condition**
- 6. Cleanliness inside the book stalls will have to be maintained by the Participant while the rest will be done by A.M.C.**
- 7. The participant can paste banners inside the allotted stall area but no material can be pasted outside of it.**
- 8. Any exhibition or sale material should be kept inside the respective stalls and no part of it can be placed in the corridor or other part of the dome**
- 9. Nothing in contravention to the existing laws or prohibited by the Law of the nation can be placed for exhibition or sale nor it could be stored.**
- 10. The participant will be allowed to use proper audio visual media at his own cost, however the same should not create noise disturbing to the visitors or the other participants**
- 11. The participant shall have to take prior intimation/ permission to hold rights table meet or any book launching or other literary event.**
- 12. The participant will have to bear the cost of insurance for any of his own material for the risk of theft or damage by any other means**
- 13. AMC will provide round the clock security of the entire book fair premises, however the participants will have to make necessary arrangement for making their personnel continuously present during book fair timings(1 pm to 10 pm)**
- 14. In case of the Book Fair is cancelled due to unforeseen and inevitable circumstances, the decision of Municipal Commissioner, AMC will be final regarding refund of the fees**
- 15. In case of dispute in any of the above, the matter will be subjected to Ahmedabad District Jurisdiction only.**
