CORRIGENDUM

Dear Bidders,

Please note that the following amendments have been made in the Tender document of Virtual-New Delhi World Book Fair-2021:

1.	The Exhibition platform should be “2D platform with 360 degree environment for the complete fair”
2.	The Clause 7 at Page No.11 may be read as “Payments should be facilitated through UPI platforms/digital wallet for each Exhibitor separately”. Facilitation service to exhibitors needs to be provided by the shortlisted bidder
3.	The Exhibition platform should have the “URL www.nbtindia.gov.in/ndwbf2021 ”
4.	The Clause 5 (Reports & Charts) at page No.9 may be read as “Google Analytics Integrated”
5.	The Clause 1 at Page No.11 (E-mail Marketing + Digital Marketing) may be read as “Deleted”
6.	The bullet point at Page No.7 (Automated matchmaking between exhibitors and visitors) may be read as “Deleted” in the Tender document
7.	The last three bullet points (Screen-share, White-Boarding & Presenter Console), Clause 2 at Page No.8 may be read as “Deleted” in the Tender document
8.	The Exhibition platform should be compatible on all “Hardware devices, operating system, & across all browsers” in the Tender document
9.	The Exhibition platform should have branding of NDWBF-2021 except for the places which are allotted to exhibitors/advertisers by NBT India. No other branding is to be put up unless specified by NBT.
10.	The terms/requirements of AR, VR & Avatar stand deleted in the Tender document
11.	The Clause: Annual turnover of Rs.2.00 Crore per annum in the last three financial years may be read as “ turnover of Rs.2.00 Crore on an average in the last three financial years ” at all places wherever it is mentioned in the tender document
12.	The Clause: Eligible agencies having minimum experience of 5 years (in developing web platform/mobile application) with Central or State Government or Public Sector undertaking/Autonomous bodies may be read as “ Eligible agencies having minimum experience of 5 years (in developing web platform/mobile application) with Central or State Government or Public Sector undertaking/Autonomous bodies/MNCs of an Exhibition of National & International repute with sizeable number of visitors ” at all places wherever it is mentioned in the tender document
13.	The bullet point at Page No.8 of Clause Point No.4 (Security of data & application with Scalability) may be read as “The proposal shall include a secure, cloud-based platform (AWS/Azure/GCP{Firebase}) , which shall allow to host online events for thousands of attendees and with restrictions of disabling downloads”.
